# में अपने चुनाव चिह्न का इस्तेमाल नहीं कर सकता : आयोग

जनसत्ता ब्यूरो नई दिल्ली, 26 अगस्त।

चुनाव आयोग ने कहा है कि जनता दल (एकी) झारखंड और महाराष्ट्र में चुनाव लड़ने के लिए 'तीर' चुनाव चिह्न का इस्तेमाल नहीं कर सकता क्योंकि यह दोनों राज्यों में झारखंड मुक्ति मोर्चा (झामुमो) तथा शिवसेना द्वारा इस्तेमाल किए जाने वाले चुनाव चिह्न 'धनुष और बाण' से मिलता-जुलता है।

चुनाव आयोग ने इससे पहले जद (एकी) को एक नियम के तहत दोनों राज्यों में अपने चुनाव चिह्न का इस्तेमाल कर चुनाव लड़ने की छूट दी थी। लेकिन अब यह छूट वापस ले ली गई है क्योंकि झामुमो ने चुनाव आयोग का दरवाजा खटखंटाते हुए कहा था कि चुनाव चिह्नों की समानता से मतदाता भ्रमित हो सकते हैं। जद (एकी), झामुमो और शिवसेना क्रमशः बिहार, झारखंड और महाराष्ट्र की क्षेत्रीय पार्टियां हैं।

चुनाव आयोग ने 16 अगस्त को जारी अपने आदेश में कहा था कि इस मामले में सभी पहलुओं पर विचार करने के बाद आयोग ने जद (एकी) को निर्देश दिया है उसे चुनाव चिह्न आदेश के पैरा 10 के तहत झारखंड और महाराष्ट्र में अब से उसके निर्धारित चुनाव चिह्न 'तीर' पर चुनाव लड़ने की छूट नहीं दी जाएगी। इस साल मार्च में आयोग ने आदेश दिया था कि झामुमो और शिवसेना बिहार में अपने चुनाव चिह्न का इस्तेमाल नहीं कर सकते हैं।

PRESIDENT DONALD TRUMP said he wants to invite Russia's Vladimir Putin to next year's G7 summit because having the country "in the room is better than having them outside."

"My inclination is to say, 'Yes, they should be in,"Trump said Monday in Biarritz, France, at the conclusion of this year's G7 meetings. Trump has previously called for fully readmitting Russia into what was once the G8. The bloc's other members have balked at welcoming back Russia, which was kicked out over its hostilities in Ukraine five years ago. On Monday, Trump again blamed his predecessor, Barack Obama, over Russia's annexation of Crimea.

## Macron says deal struck with US on taxing tech giants

**DONALD TRUMP AND Emmanuel Macron's governments** have struck a deal to end a feud over France's tax on some tech giants, the French president said. "We have reached a very good agreement," Macron said at a joint news conference with Trump at the conclusion of the Group of Seven summit in Biarritz, France. Trump had threatened to impose tariffs on French wine imports in response to France's planned tax. He didn't directly answer when asked to confirm the deal, instead joking that "I can confirm the first lady loved your French wine." The law Macron signed imposes a 3% tax on the revenue of technology giants such as Facebook and Amazon. Trump objected to France taxing US-based companies.

The tax, retroactive to January, affects companies with at least €750 million in global revenue and digital sales of €25 -BLOOMBERG million euros in France.


