Sub: Report on Postal Ballot including E-voting process pertaining to Sir Shadi Lal Enterprises Limited (CIN:L51909DL1933PLC009509)

1. The Board of Directors of the Company at its meeting held on 23rd September, 2019 has appointed me as a Scrutinizer for conducting the postal ballot process including E-Voting in a fair and transparent manner.
2. I have scrutinized the voting that has taken place by remote E-voting and through postal ballots.
3. I submit my report as under:
 - (a) The Company has completed on 8th November, 2019 the despatch of postal ballot forms alongwith postage prepaid business reply envelopes to its Members whose name(s) appeared on the Register of Members/list of beneficiaries as on 17th October, 2019.
 - (b) Particulars of all the postal ballot forms received from the members have been entered in a register separately maintained for the purpose.
 - (c) The postal ballot forms were kept under my safe custody before commencing the scrutiny of postal ballot forms.
 - (d) The postal ballot forms were duly opened in my presence and scrutinized and the shareholding was matched/confirmed with the Register of



Members of the Company /list of the beneficiaries as on 17th October,2019.

- (e) All postal ballot forms received upto the close of working hours on 8th December, 2019, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- (f) No envelopes containing postal ballot forms have been received after 8th December, 2019.
- (g) Envelopes containing postal ballots form returned undelivered aggregated to 434. These envelopes were not opened and they are kept separately.
- (h) I did not find any defaced or mutilated ballot paper.
- (i) Two postal ballot forms with 506 voted have been rejected as they were invalid as per instruction No. 6 given on the Postal Ballot Form.
